Part III: It is customary for each World Science Fiction Convention to pass along a share of its residual funds to the next three scheduled conventions. Accordingly, Chicago Worldcon Bid intends to make donations to the 71st, 72nd and 73rd World Science Fiction Conventions. The only donation made in 2012 was to the 72nd World Science Fiction Convention, which will be held in London, England, August 14-18, 2014. The sponsor of that convention is London 2014 Ltd., trading as Loncon 3 ("Loncon"). Loncon does not qualify for tax exemption under the very narrow rules set forth in United Kingdom tax law, but Chicago Worldcon Bid has confirmed that its activities will be essentially identical to Chicago Worldcon Bid's and would qualify for exemption under section 501(c)(3) if Loncon were a United States organization.

Chicago Worldcon Bid donated \$20,000 to Loncon in 2012 and an additional \$10,900 in 2013. The grants were made by check and were for the general support of Loncon's educational activities.
