Harlech Castle is renowned for its spectacular location on a rocky crag, overlooking the sea and framed by the mountains of Snowdonia beyond. Not only is the site picturesque but it is also eminently defensible and King Edward I's skilful master mason exploited this unique position to the full.

Following the death of the Welsh prince, Llywelyn ap Gruffudd, in 1282, Harlech was one of a series of castles established in north Wales by King Edward I to secure the newly conquered principality. Begun in May 1283, the castle was raised in two main building phases, based on the concentric — walls within walls — principle and perfectly adapted to the restricted space of the rocky outcrop. Symmetrical in design, with four corner towers and an impressive gatehouse, and built to take full advantage of its seaside location, the castle was largely complete by 1289.

The castle was strengthened in 1295 and again in 1323–24, but it was during the Welsh rebellion led by Owain Glyn Dŵr that Harlech once more came to prominence.

In 1404 the castle fell to the Welsh and was occupied by Glyn Dŵr's court and family until 1409 when it was retaken by the English. Two more sieges were to follow: first, during the Wars of the Roses, when Harlech was taken by Yorkist forces in 1468 — an occasion that reputedly gave rise to the famous song, *Men of Harlech* — and finally during the Civil War, when it was surrendered to parliamentary forces in 1647. Although parts of the castle were rendered untenable, fortunately the order to demolish it was never carried out and from the eighteenth century the castle began to attract the attention and interest of topographical artists, including J. M. W. Turner, Paul Sandby and John Sell Cotman.

The castle has been maintained by Cadw since 1984 and in 1987 Harlech — together with the castles at Beaumaris, Caernarfon and Conwy — was inscribed on the World Heritage List as an historic site of outstanding universal value.

# A Bird's-Eye View of Harlech Castle

From the South-West

**1 Bridge Towers** — The footings of two towers in the east ditch are all that remain of a fortified bridge added to this side of the castle in 1323–24 (pp. 9, 18).

**2 Gatehouse** — A magnificent construction that dominates the whole castle from its position astride the east curtain wall. The gate-passage includes a series of defensive obstacles, with guardrooms to either side. The two upper floors comprise grand suites of apartments, one for the constable, and the second perhaps for visiting dignitaries (pp. 18–25).

**3 Gatehouse Inner Façade** — The design included six great windows, three to each upper floor. As a whole, it is one of the most striking compositions of military architecture from thirteenth-century Britain (p. 23).

**4 North-East Tower** — A doorway in the corner of the courtyard allows access to the upper floors and battlements. A trapdoor at first-floor level provided the only means of entry to a deep circular dungeon (p. 27).

**5 South-East Tower** — Two seven-sided rooms, with corner fireplaces, are set over a circular dungeon-like basement (p. 27).

**6 South-West Tower** — Completed in 1289, this tower was surmounted by a turret. On the external face, an original line of sloping putlog holes survives from spiral scaffolding used during construction (pp. 27, 31).

**7 North-West Tower** — Like the south-west tower, it contained four five-sided rooms. It was completed, with its turret, in 1289 for £122 15s. 6d. (pp. 27–28).

**8 Chapel** — Built against the north curtain wall, it must have served as a garrison chapel, with two more private chapels in the gatehouse (p. 28).

**9 Well** — Located next to a window embrasure against the north curtain (p. 28).

**10 Hall** — The hall was built against the west curtain wall. It was equipped with four windows looking out towards the sea (p. 30).

**11 Outer Ward** — This was of concentric design, but the nature of the site meant it was somewhat narrow and constricted (pp. 17, 31).

**12 Ditch** — The castle was most vulnerable to attack from the east and the south. On these two sides, a deep and wide rock-cut ditch was set out on a concentric line to the outer ward (pp. 17, 31).

**13 Corbelled Latrine** — Set over the rock-cut ditch, this unusual feature can be paralleled in castle architecture in Savoy (pp. 29, 31).

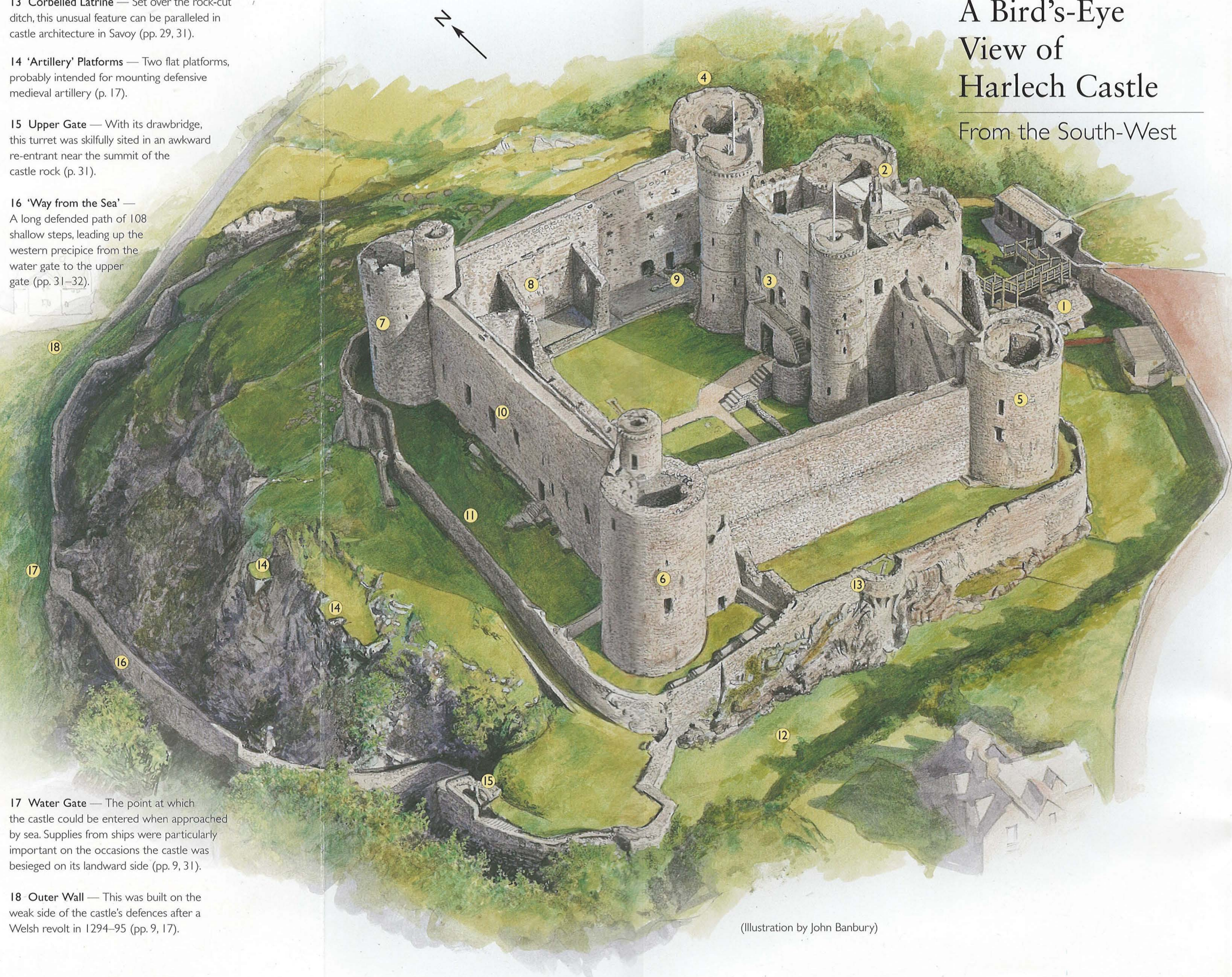
**14 'Artillery' Platforms** — Two flat platforms, probably intended for mounting defensive medieval artillery (p. 17).

**15 Upper Gate** — With its drawbridge, this turret was skilfully sited in an awkward re-entrant near the summit of the castle rock (p. 31).

**16 'Way from the Sea'** — A long defended path of 108 shallow steps, leading up the western precipice from the water gate to the upper gate (pp. 31–32).

**17 Water Gate** — The point at which the castle could be entered when approached by sea. Supplies from ships were particularly important on the occasions the castle was besieged on its landward side (pp. 9, 31).

**18 Outer Wall** — This was built on the weak side of the castle's defences after a Welsh revolt in 1294–95 (pp. 9, 17).

# Introduction

*'Bendigaid Frân, the son of Llŷr, was the crowned king of this island, and exalted with the crown of London. And one afternoon he was at Harlech in Ardudwy in his court. And they were sitting upon the rock of Harlech, above the sea ...'*

Framed in countless pictures with the mountains of Snowdonia behind it and the sea not far from its foot, Harlech's spectacular situation has made it one of the most familiar castles in the British Isles. But not only has it an unsurpassed natural setting; as a piece of castle-building Harlech is also unrivalled. It is the creation of an architect of genius. The master mason's skilful adaptation of the natural strength of the site to the accommodation and defence requirements of his patron has produced a building that combines a marvellous sense of power with great beauty of line and form. Now some seven centuries old, Harlech was completed in all essentials from ground to battlements in a mere seven years. It is a strikingly successful realization of a single design concept, perfectly attuned both to its purpose and its natural surroundings.

This guidebook sets out firstly to explain when and why the castle came to be built, who its architect and builders were, and how the work of building was carried out. Secondly, the castle's subsequent history is traced through the centuries, and some of the episodes of national significance in which it had a part to play are recalled. Finally, there is a tour of the castle buildings, outlining the plan and layout of the stronghold, and explaining the purpose of the walls and towers and the interior buildings. All the principal features are indicated, and details of interest

pointed out. In short, the purpose of the tour is to make the castle tell its own story. To the interested visitor, a castle like Harlech is constantly saying, 'if you want to know about me, look carefully at me and I will tell you'. For most of us, buildings speak in a language difficult to understand without help. Part of the guidebook's role is to translate and interpret, to recall the forgotten and help the castle come alive again.

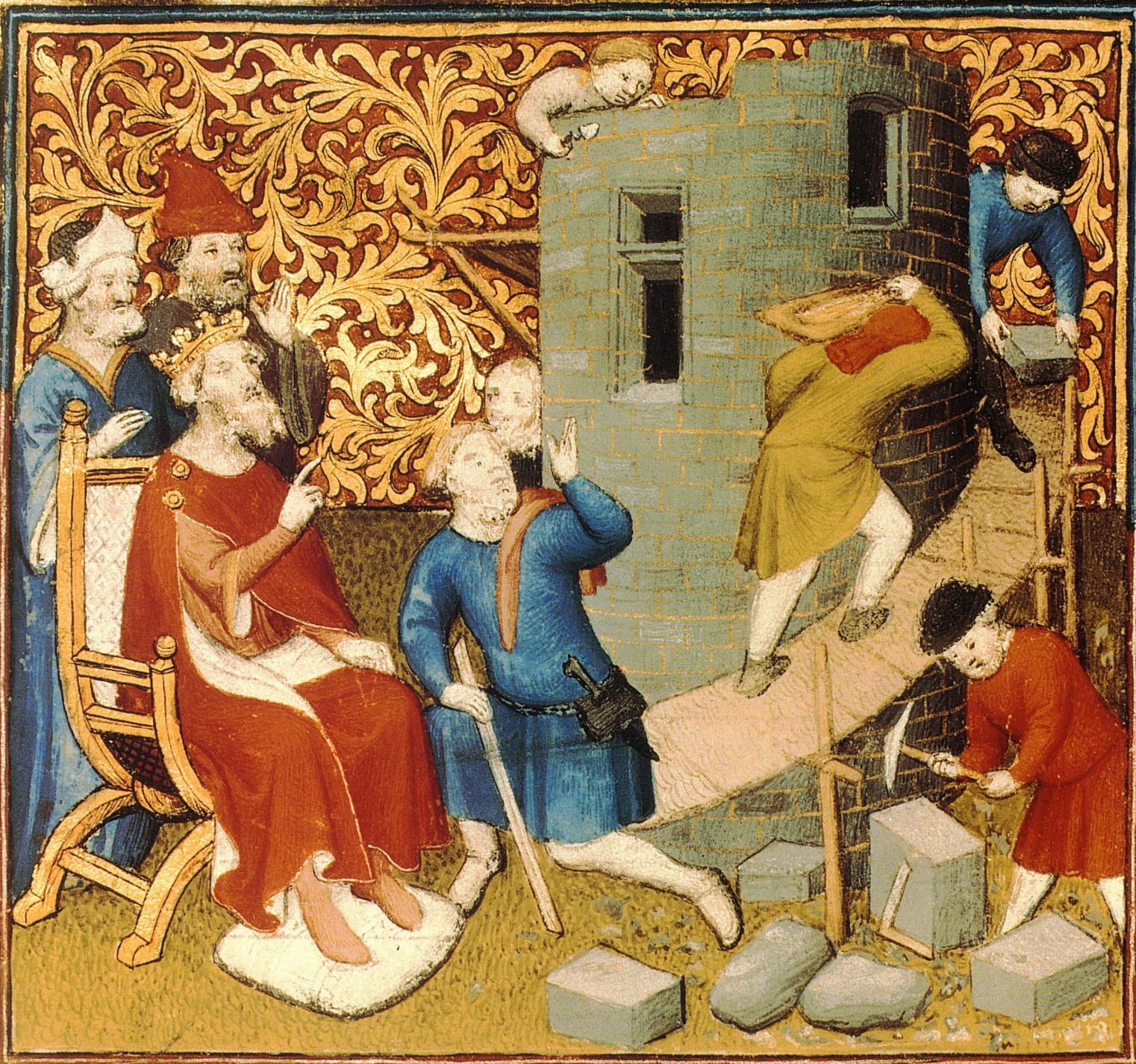

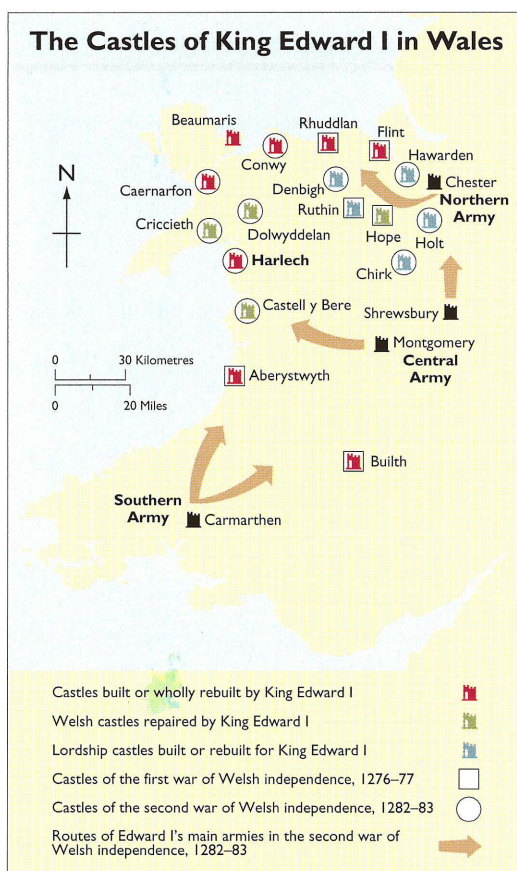
## The Building of the Castle: 1283–89

Harlech is one of a group of great new castles built in or on the borders of north Wales for King Edward I (1272–1307) of England in the last quarter of the thirteenth century. There were fourteen of them, with Flint, Rhuddlan, Ruthin, Hope, Builth and Aberystwyth begun in 1277; Conwy, Harlech and Caernarfon, which were begun in that order between March and June 1283; Denbigh, Hawarden, Holt and Chirk which were constructed after 1284; and Beaumaris, the last of the group, begun in 1295. To complete the list of Edwardian castle works in north Wales, one has also to include the repair and rebuilding — from 1283 onwards — of Dolwyddelan, Criccieth and Castell y Bere, war-damaged strongholds of the former Welsh princes.

Neither history nor archaeology furnish any evidence to suggest that Harlech itself had formerly had a castle of the princes. In Welsh mythology, however, the place is associated inseparably and for ever with the legend of Branwen, the daughter of Llŷr, the opening lines of which (p. 3) are the proper prologue to the story that follows.

In the month of May 1283, Harlech emerges from the realms of folk-tale and myth into the light of recorded fact. Six months earlier, in December 1282, Llywelyn ap Gruffudd, the first and last Welsh prince of all Wales, had been killed near Builth. In January, the castle of Dolwyddelan in Snowdonia had fallen to the English after a hard-pressed siege. In April, the Welsh garrison at the castle of Bere in the southern folds of Cader Idris also surrendered after a ten-day siege.

Dolwyddelan's capture opened the way for King Edward's northern force to advance down the Conwy valley. Building of the new castle and walled town, which still stand near the river's mouth today,



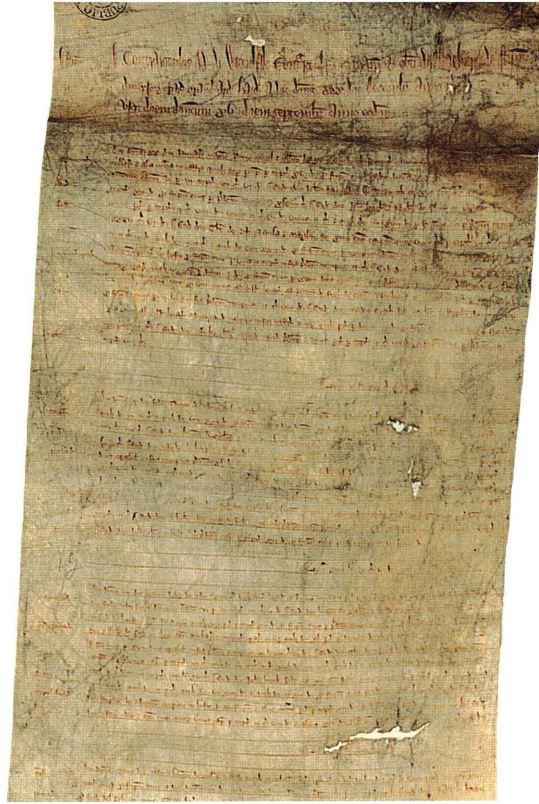

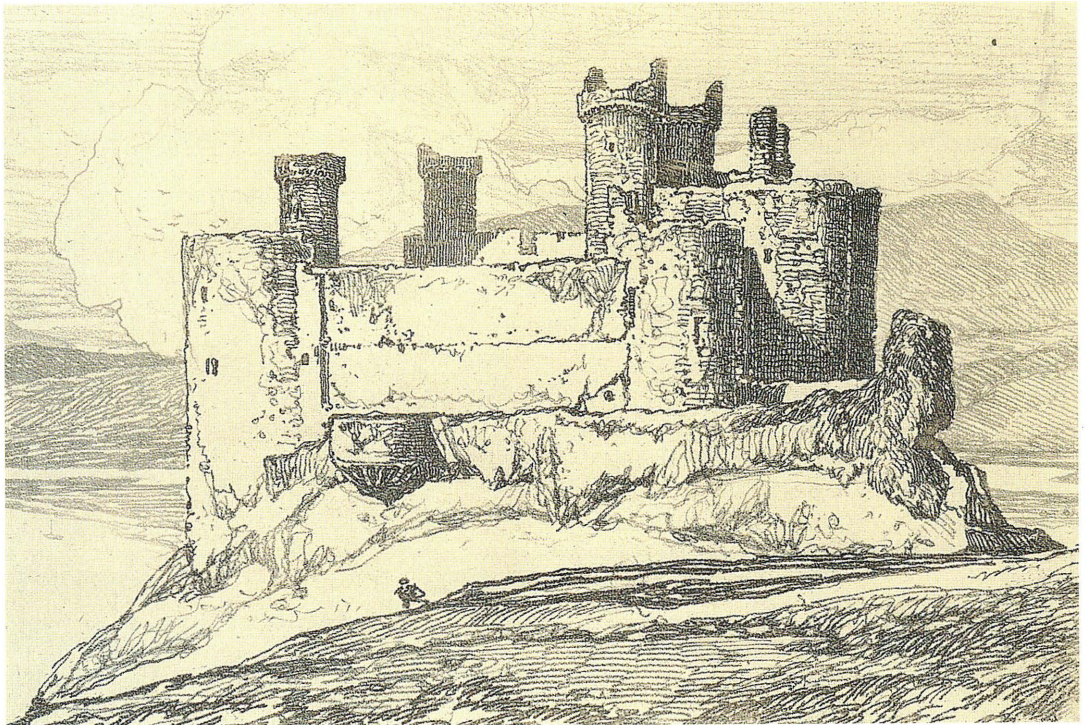
From 1283, documentary sources allow us to trace the progress of the works at Harlech. In January 1286, just 60 men were engaged in construction. By mid-summer, with work at its height, nearly 950 were working at the site. This section of the annual accounts records some of the items of expenditure for 1286 (Public Record Office, E 101/485/26).



was commenced in March. A month later, the elimination of Castell y Bere cleared the way for the central force of 560 infantry under King Edward's Savoyard lieutenant, Sir Otto de Grandison (1238–1328), to march up through the Welsh districts of Meirionydd and Arduwy to Harlech. Work on the new castle was begun immediately. Between 14 and 20 May, two panniers containing £100 in hard cash were sent under guard from the Cistercian abbey of Cymer to the site chosen for the new castle 'for the works there'. And a month later we read of twenty stonemasons and quarriers being sent off from the newly established base at Conwy to Harlech, with a packhorse to carry their tools on the two-day journey across the mountains. In July, another fifteen masons and a squad of carpenters followed on the same journey. Three years later, with the work at its height in the summer of 1286, nearly 950 men were employed — 227 masons, 115 quarriers, 30 smiths, 22 carpenters and as many as 546 labourers and minor workmen.

The overall plan of the castle was determined at the very outset of the works. Thereafter, by combining the evidence of our eyes with what we can learn from surviving records, we can see by

what stages the construction of the stronghold gradually moved forward to completion.

The earliest stage was achieved in the first few building seasons, and was probably completed before construction work stopped for the winter of 1283–84. Evidently, this phase saw the erection of the main inner curtain wall of the castle. But it was only raised to such a height and thickness as would provide — in the shortest possible time — a strong defensible enclosure within which the garrison and workforce could be accommodated as further building proceeded. Looking carefully, especially at the outside of the north and south curtains, you will see a horizontal break-line in the masonry at a height of about 15 feet (4.5m) from the ground. The build of the stonework above this line differs from that below. Evidence of a similar change can also be detected on the two eastern corner towers. The north, south and west curtains also show evidence, up to the same height, of a vertical break. Each of these sections of wall was at first built only to about two-thirds of its ultimate thickness. In the case of the north and south curtains, it is the outer face which is the earlier and thicker, whereas on the west curtain it is the inner side of the wall. A works account survives which actually mentions the final thickening and heightening of the walls as having been completed in 1289.

The 1284 and 1285 building seasons are likely to have seen substantial progress with the construction of the lower parts of the great gatehouse, built as it was astride the line of the eastern curtain. At the same time, headway was probably also made on the concentric outer curtain wall, with its turreted gateways to the east and to the north, and the great corbelled latrine chute projecting out over the rock-cut ditch to the south. A record survives of a major payment being made for work during the 1285 season on the cutting of this ditch. From another record, it is clear that by the end of the same year certain rooms in the gatehouse were being prepared for occupation. They were intended for the newly-appointed constable of the castle, Sir John de Bonvillars (d. 1287).

Building expenditure at Harlech rose to a peak of nearly £240 a month over the fourteen months from September 1286 to November 1287. It was to average rather less than half this figure over the two succeeding years. A fragmentary account belonging

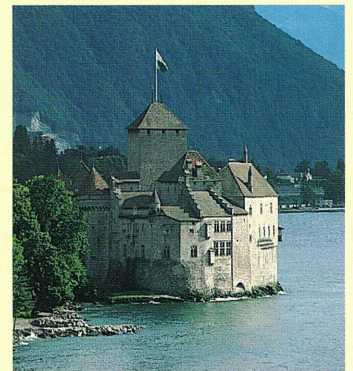
## Master James of St George



**L**ike the other north Wales Crown castles that were its contemporaries, Harlech's construction was directed by the brilliant James of St George. Born about 1235, James was a highly-paid master mason and military engineer who came to Wales from distant Savoy in 1278. He had earlier worked as the chief household architect for two of the counts of Savoy: Peter II (1263–68), and Philip (1268–85). King Edward I secured his services by arrangement with Count Philip, and brought him to Wales to superintend his new castle-building programme.

In July 1290 the king appointed him constable of Harlech, a fitting honour which for the next three years Master James held in conjunction with his post as master of the works. He resided with his wife, Ambrosia, in all probability in the great gatehouse which stands to this day as witness to his creative skill. In 1295, James was granted a life pension, together with the manor of Mostyn in north-east Wales. In May 1309 the manor was described as 'late of Master James of St George, deceased'.

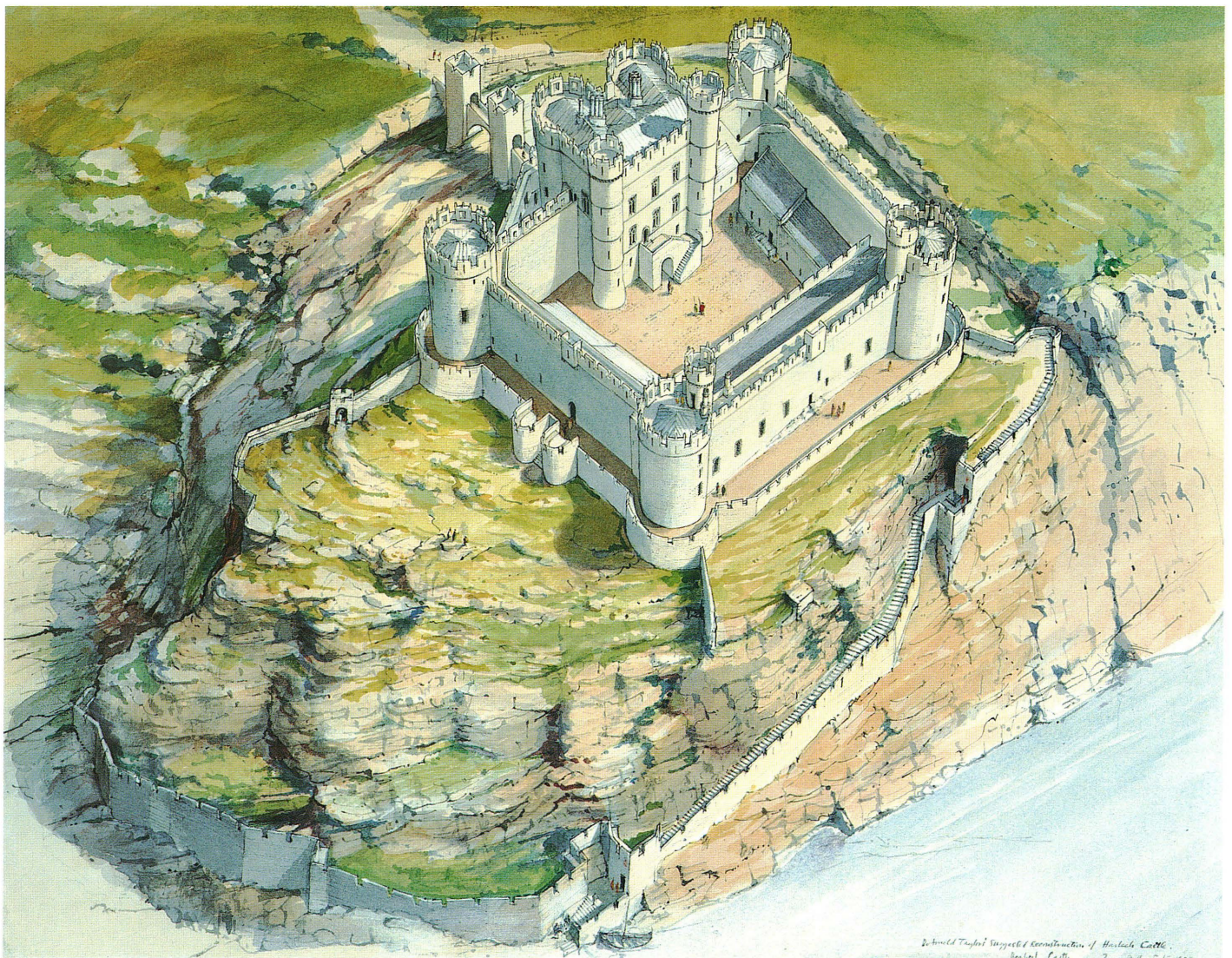

to the end of the year 1289 shows that by then the building of the castle was virtually finished. The two western towers — 'the towers towards the sea' — had been added in a single operation, and their turrets and those of the gatehouse all stood complete to their battlements. The main curtains had also been thickened and, with the eastern corner towers, carried up to their full height. The long sloping path up from the water gate — 'the way from the sea' — had already been constructed, together with the wall closing off the south-west end of the ditch and the corresponding wall running out to the edge of the rock from the mantelet below

the north-west tower. Inside the castle ward, the walls of the hall, the chapel, the pantry and kitchen had all been built.

The composition of the permanent garrison had been established in 1284. It was to comprise a constable, 'together with 30 fencible men of whom 10 shall be crossbowmen', one chaplain, an artiller, a smith, a carpenter and a mason, 'and from the others shall be made janitors, watchmen, and other necessary officers'. By the end of the decade, the castle whose defence and maintenance was entrusted to them thus stood to all intents and purposes complete.







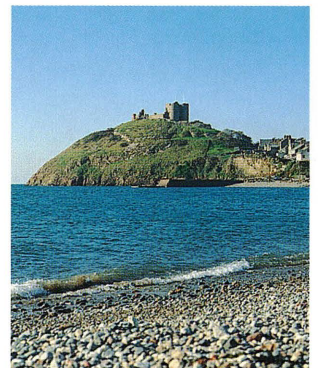

## Secondary Works

Harlech's viability was first put to the test at the time of Madog ap Llywelyn's rising in 1294–95. During this widespread national revolt, the castle was entirely cut off by land. Indeed, the same was true of Criccieth, the Welsh castle across the bay which had been occupied and repaired by the English since the war of 1282–83. But the coastal position of the two strongholds enabled them to be supplied and victualled from Ireland by sea, and both held out. As soon as the war was over, steps were taken to strengthen one remaining area of potential weakness at Harlech. Although the defended 'way from the sea' had already been constructed up the flank of the western precipice, the castle rock to the north had been left to rely on the natural protection of the deep ravine and waterfall bounding it on that side. Orders were now given for the rock to be enclosed with a wall of stone and lime, and a new tower was built over or near the water gate.

More than a quarter of a century later, in 1323–24, the castle was further strengthened. Harlech had probably become a main base for the forces led by Sir Gruffudd Llwyd, sheriff of Merioneth, in support of King Edward II (1307–27) against the Mortimers. It was at this time that the bridge approach from the east was strongly fortified with the erection of two towers. Constructed in line, one 60 feet (18m) the other 40 feet (12m) high, the towers sprang from the base of the ditch in front of the entrance gateway. Their stumps can be seen beside and below the modern approach path and stairway. A sixteenth-century description of the castle shows that in the centre — between the two towers — there was a stone-arched bridge, with a drawbridge at either end.

Harlech seems to have been involved in little activity during the remainder of the fourteenth century, but an awareness of its strategic importance is perhaps indicated by the fact that for forty years, from 1332 to 1372, the constablenesship was in the hands of Sir Walter Manny, one of the ablest soldiers to serve King Edward III (1327–77), and one of the most prominent figures of the reign.

## Harlech and Owain Glyn Dŵr

Harlech Castle played a key role in the events and incidents that marked the great Welsh uprising of about 1400 to 1414. Led by the charismatic Owain Glyn Dŵr, the revolt was to prove the last major Welsh rebellion against English rule. By 1403, the scale of the revolt had become truly national. In the north and west, the castles at Aberystwyth, Beaumaris, Caernarfon and Harlech had become isolated outposts of English authority. An inventory of military supplies at Harlech taken in June of that year shows just how difficult it was for the garrison to mount an effective defence of the stronghold. There were just three shields, eight basinets, six lances (four lacking heads), ten pairs of less than useful gloves, four guns, and various stocks of iron and lead.

After long sieges, Harlech and Aberystwyth finally fell into Welsh hands, probably in the closing months of 1404. Their control gave Owain unfettered authority in central Wales. Harlech became the residence of his court and his family, and with Machynlleth it was one of two places to which he summoned parliaments of his supporters. There is a tradition that at one of these, and Harlech is perhaps the more likely, he was formally crowned as prince of Wales in the presence of envoys from Scotland, France and Spain.

In 1408–09, Harlech was again under siege; this time a Welsh garrison suffered under persistent cannonading. One of the massive cannon employed by the attacking English force bore the name 'the king's daughter'; we have a reference to it bursting during the siege. Indeed it may be to this bombardment that we owe the heap of stone cannon balls to be seen on the floor of the gatehouse, and to their battering that we should ascribe the loss of most of the outer curtain wall along the east and south sides of the castle. Few details have come down to us of Harlech's recapture by Harry of Monmouth, prince of Wales — the future King Henry V (1413–22) and victor of Agincourt — but according to one chronicler the prince's contemporary siege of Glyn Dŵr's garrison at Aberystwyth was conducted 'by mynes and all manner of engins that were thought needful for the distruction of them and of there castle'. Harlech appears to have fallen in early February 1409, as much due to a lack of supplies and exhaustion as to the effect of cannon balls.



## Harlech in the Wars of the Roses

Sixty years later, Harlech was playing a prominent part in the Wars of the Roses (1455–85). In the summer of 1460 it gave shelter to Queen Margaret of Anjou (d. 1482), the wife of King Henry VI (1422–61, 1470–71), and in 1461–68 it was held for the Lancastrians by a Welsh constable, Dafydd ab Ieuan ab Einion. After almost a decade as a thorn in the side of the Yorkist faction, in 1468 King Edward IV (1461–70, 1471–83) determined upon the necessity of capturing this stubborn outpost of Lancastrian resistance. 'Kyng Edward', wrote the chronicler John Warkworth, 'was possessed of alle Englonde, excepte a castelle in Northe Wales called Harlake, which Sere Richard Tunstall kepte, the qwiche was gotene afterwards by the Lord Harberde'.

In fact, the king empowered Lord William Herbert (d. 1469) of Raglan, *Lord Harberde*, to raise a substantial force, variously estimated at between 7,000 and 10,000 men. Herbert and his brother, Sir Richard Herbert (d. 1469), marched northwards with two wings of their great army converging on Harlech. The ensuing siege was graphically described by the poet, Hywel Dafli, who told of men being 'shattered by the sound of guns', with 'seven thousand men shooting in every port, their bows made from every yew tree'. The Lancastrian defenders held out for less than a month, surrendering the castle on 14 August. Fifty prisoners were taken, including Dafydd ab Ieuan ab Einion who had kept 'little Harlech for so long, alone faithful to the weak crown'.

It was the Yorkist siege of 1468 which is traditionally supposed to have given rise to the well-known song, *Men of Harlech*.

## The Sixteenth Century

There is no record that the castle was repaired after the Glyn Dŵr sieges. When we next hear of Harlech, in 1539, it is in a report of Crown surveyors who declared that Conwy, Caernarfon and Harlech were all wholly unfurnished with means of defence and — in the event of invasion by the French or the Scots — incapable of being

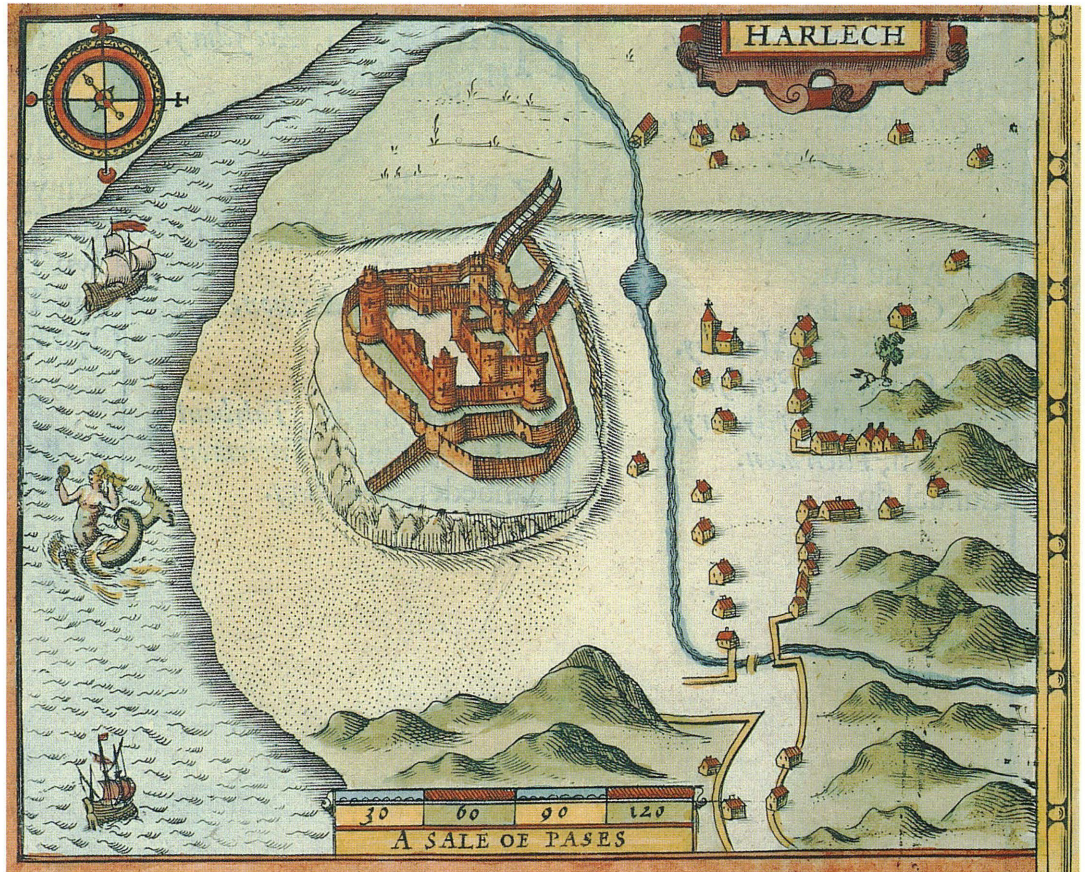

defended one hour. Another survey, of 1564, reported the interior of nearly every tower in the castle to be 'in utter ruin', the hall and chapel were roofless and the other buildings in the courtyard 'utterlie in ruyn and prostrate'. The place of the drawbridges was taken by makeshift constructions of timber and planks, themselves 'in greate decaye'.

In the reign of Queen Elizabeth I (1558–1603) it was directed that the Merioneth Assizes be held at Harlech and, for this purpose, at least the principal rooms in the gatehouse must have been maintained in occupiable condition. A paper of 1604 sets out the arguments 'for the keeping of the Sessions, etc., at Harlech', rather than at Bala where the justices preferred.

The paper points out that the castle is: 'as yet kept in somme better reparacion than anye of his Majesty's Castles in North Walles by reason that the Justices of the Assize, Sheriffe and Plenotarye, with there trayne, doe vse, when the assizes are kepte in that Towne, to lie and keepe their diet within the said Castle. At which tyme the said Castle is aired, scowred, cleansed, and

some charges bestowed by every Sheriffe towards the reparacion thereof at every time they doe vse to resort thither to keepe the Sessions. If the Justices had not resorted to it, the Castle had been quite ruinated and decayed, but if the Sessions continue the Castle will be kept in reparacion without charge to His Majesty'.

It is stated that the: 'common gayle of the Castle is usually kept in the said Towne, and the poor prisoners therin relieved by the inhabitants thereof ... , but the Justices now, respecting ther owne ease more than the good of the towne and ease of the cuntry, doe most commonlie vse to keepe their sessions at Bala, being a very fylthie dyrtie towne, without any lodgings fitt for gentlemen to lie, and a place farre remote and very unconuenient for any general mytings'.

It is shown that it is very necessary that the Castle: 'standinge upon the sea side, with havnes of both sides, be maintained and kepte in reparacion, so that his majestie may easilie (if need be) fortifie the same — as well as keepe the COUNTRY in awe from anye insurrection, or rebellion, as alsoe to resist and withstand foraine powers'.



## The Civil War and After

Forty years later, many of the medieval castles of England and Wales saw a last brief phase of military activity in the Civil War of 1642–48. Some of them, such as Donnington in Berkshire, Old Basing in Hampshire, or Denbigh and Raglan in Wales, were subjected, sometimes more than once, to protracted siege and bombardment. From the spring of 1644, Harlech was defended for the king by its constable, Colonel William Owen (d. 1670) of Brogryntyn. The castle seems to have been under siege by a parliamentary force from late June 1646. When the surviving garrison of 16 officers, gentlemen and invalids, together with 28 common soldiers, finally surrendered to Major-General Thomas Mytton (d. 1656) on 15 March 1647, Harlech was the last royalist stronghold of all to be lost. Its fall signified the end of the Civil War.

The parliamentarians are said to have rendered the castle untenable and to have destroyed the two gatehouse staircases (both renewed in modern times). Fortunately, an order to demolish it was not proceeded with, and though bereft of its floors and its roofs, its glass and its wood and its lead, its main structure still stands very largely complete, as striking a monument as any of its north Wales contemporaries to the skill and art of the

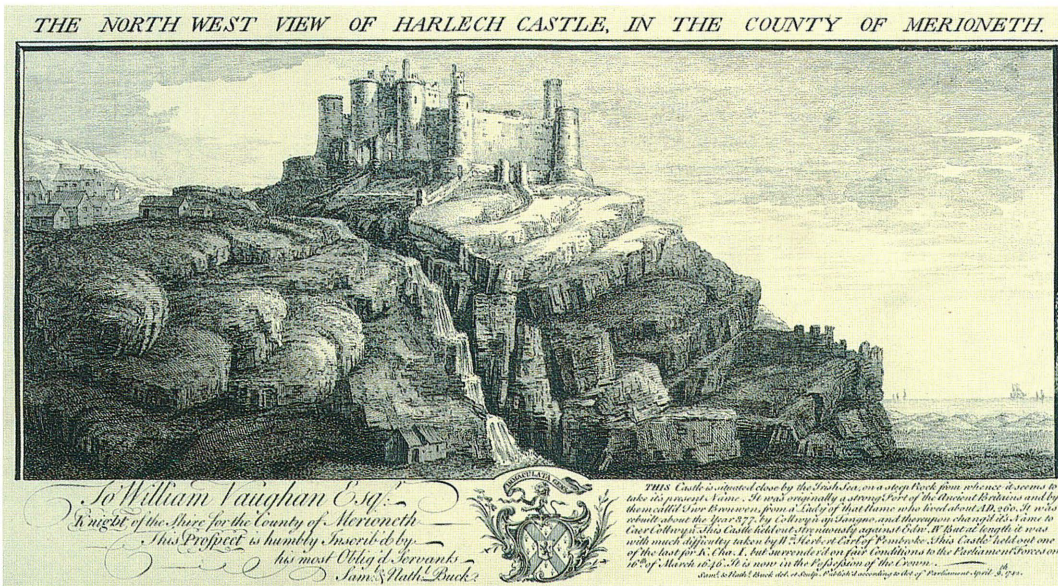
castle-builders who conceived and created it towards the close of the thirteenth century.

From the eighteenth century, the castle began to attract the interest of topographical artists. The earliest depiction is the engraving by the brothers Samuel and Nathaniel Buck, published in 1742. When the travelling writer Thomas Pennant saw Harlech in 1770 he described it as 'a small and very poor town, remarkable only for its castle,

which is seated on a lofty rock ... a noble square building'. In the late eighteenth century, and on into the nineteenth century, it was the superb Picturesque qualities of the site which continued to attract the attention of artists such as Paul Sandby (1731–1809), J. M. W. Turner (1775–1851), John Varley (1778–1842), John Sell Cotman (1782–1842) and Henry Gastineau (1791–1876).

Harlech has always remained a property of the Crown. Until transferred to the Office of Works in 1914, responsibility for its care — as part of the Merioneth Crown Estate — lay with the Office of Woods and Forests, who carried out many useful repairs, including the renewal of the arches over the entrance passage through the gatehouse. The general overhaul of the stonework, together with the excavation of the main ward and exposure of wall foundations to original levels was carried out under the direction of Sir Charles Peers (1868–1952) during the years following the end of the 1914–18 war. In 1969 ancient monuments in Wales became the responsibility of the Welsh Office, and the castle is now maintained on behalf of the National Assembly for Wales by Cadw: Welsh Historic Monuments.

In 1987, Harlech Castle — together with Beaumaris Castle, Caernarfon Castle and town walls, and Conwy Castle and town walls — was inscribed on the World Heritage List as an historic site of outstanding universal value.

# A Tour of Harlech Castle

## Siting and Plan

Even in the context of such rivals as Conwy, Caernarfon and Beaumaris, Harlech is scenically perhaps the most sublime of all the north Wales castles. Its rugged rock-based walls and towers achieve a serene and abiding harmony with the nearby hills and distant heights. No visitor who can spare the time should miss the reality of the well-known view of the castle from the south, with Snowdon's peak as the climax to the backcloth of mountain summits, and with the flat green lands of the *morfa* running out to the sandhills and the silver sea at the panorama's western edge. The viewpoint for this lies just south of the town, on an open rocky knoll beside the Barmouth road.

The castle is splendidly sited on a bold and rugged promontory, rising barely 200 feet (60m) above sea level. This headland of rock is a spur of the Harlech Dome, a famous geological feature comprising a hard, tough grit or sandstone belonging to the lower part of the Cambrian system. Jutting out towards the sea, and falling away steeply on all sides except the east, the site has great natural military strength. It provided the ideal platform for the architectural masterpiece that Edward I's builders erected on it.

The castle proper occupies a levelled area towards the south side of the headland. The inner ward, which is the heart of the castle, forms a quadrangle surrounded by curtain walls. On the east and west sides, these walls are parallel, but to the north and south they splay outwards to accommodate the great gatehouse. The gatehouse itself dominates the whole group of buildings from a position astride the centre of the eastern curtain. A lower and slighter outer curtain wall closely envelops the inner ring of walls, gatehouse and four corner towers. This provides for a concentric, but somewhat narrow and constricted, outer ward.

The only directions from which a land-based attack could conceivably be mounted on the castle were to the east and south. On these two sides, a deep and wide rock-cut ditch was set out in a further concentric line to the outer ward. This ditch was never intended to be water-filled; its scale alone was enough of an obstacle to mining or the bringing up of siege engines.

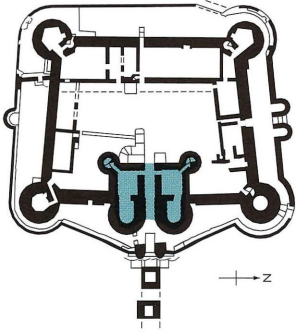
Beyond the heart of the castle, a large enclosed area of rock extends to the north and is bounded by a ravine and a waterfall. And to the west, the face of the headland falls away precipitously to sea level. Here, at the foot of the castle, was a water gate. How near the seashore came up to this gate in the thirteenth century is not known with any certainty, but a channel must have been made to allow ships to approach it and unload. A path from the water gate up to the castle is ledged against the overhanging rock, and is protected from above by two 'artillery' platforms which still survive.

## The Gatehouse

Today, most visitors approach the castle down the short hill from High Street and enter it from the east or main gate. Seen from the car park, only the ditch bridge towers, much of the low outer curtain wall, and the high battlements are wanting. What remains continues to convey an overwhelming sense of symmetry in design. It presents an image of uncompromising power and impregnability towards the only possible direction of attack.

From the ticket office, a modern timber bridge and steps lead up towards the main gate. Behind the ticket office, the children's playing field is on the site of the filled-in castle pond. Before climbing up to the main gate it is well worth pausing to consider some of the exterior details.

### External Features

Looking at the gatehouse, in the centre you should note the lancet window of the lower chapel [1], with a large formerly-grilled window in the towers to either side [2]. Above you will see the corresponding window arrangement of the chapel [3] and flanking rooms of the top floor [4]. Above again there is a chamfered stringcourse [5], here surviving complete and binding the whole architectural composition together. It also marks the base of the battlemented parapet in which one whole arrowloop and several bases still remain [6]. On the left-hand tower only,

there is a great sweeping slope of six putlog holes of the helicoidal or spiral scaffolding used by the original builders [7]. Notice also how the solid turrets [8] of the outer gate are pushing forward in front of the inner towers in a commanding salient. These turrets are corbelled out to rise from a smooth sloping apron of stone, itself rising sheer from the rock-cut edge of the deep eastern ditch. You will see how the remains of the outer curtain [9], battered down in one or other of the castle's sieges, fall away to left and right of the gate turrets. The height and now lost battlementing of this outer curtain would originally have been maintained all round the great outer bastions or mantelets at the south-east and north-east angles and along the south and north sides.

You are now ready to enter the heart of the castle, and should ascend the modern timber staircase beside and above the foundations of the two early fourteenth-century bridge towers.

At the top of the staircase, you will be standing at the point where an inner drawbridge pivoted to come down against the nearer of the bridge towers. Looking back, you must envisage an elevated passage leading into the castle at this level. It ran through arches in both of the bridge towers, and was supported on a stone-arched centre bridge (see reconstruction p. 8). The whole arrangement continued on towards the main gate-passage, through which access is still gained to the inner ward.

### The Main Gate-Passage

Having passed through the outer gate, we come to the principal entry to the inside of the castle. This, the main gate-passage, is itself worth careful inspection. It housed a succession of obstacles, and each section of the passage could be used to isolate and detain any would-be entrant by closing a barrier behind him before opening the one in front. Indications of all these barriers are still visible.

To begin with, outside the first arch, a two-leaved wooden door opened outwards against the flat sides of the flanking towers, shaped for this purpose. The doors were secured by a heavy drawbar, the hole for

which can be seen running into the thickness of the wall on the left, immediately inside the arch. Behind the doors, just in front of the next arch, there was a heavy portcullis, the grooves for which remain intact. There were arrowloops from the guardrooms on either side, covering an entrant as he moved forward towards the next barrier. This was a second portcullis, situated in front of the next arch, and beyond this was a second two-leaved door opening inwards, with the hole for the sliding drawbar again visible. Then comes the main length of the passage, at the end of which doorways on either side lead through to flanking porters' rooms. From these rooms, winding stairs lead up to the residential apartments above. Overhead, you will see the springers of three intermediate unrestored arches which carried the floor of the room over the passage. Beyond the two side doorways are the grooves for a third portcullis barring entry to the courtyard, and in front of this there was possibly a third two-leaved door opening inwards, but all evidence for this has now gone.

Look up into the narrow space between the last two arches and you will see, through a square opening in what is the window seat of the room above, a small hole situated in the ceiling of the window embrasure. A pulley wheel was suspended at this point, carrying the rope or chain used to raise and lower the portcullis. Similar evidence is also detectable above the other two portcullises.

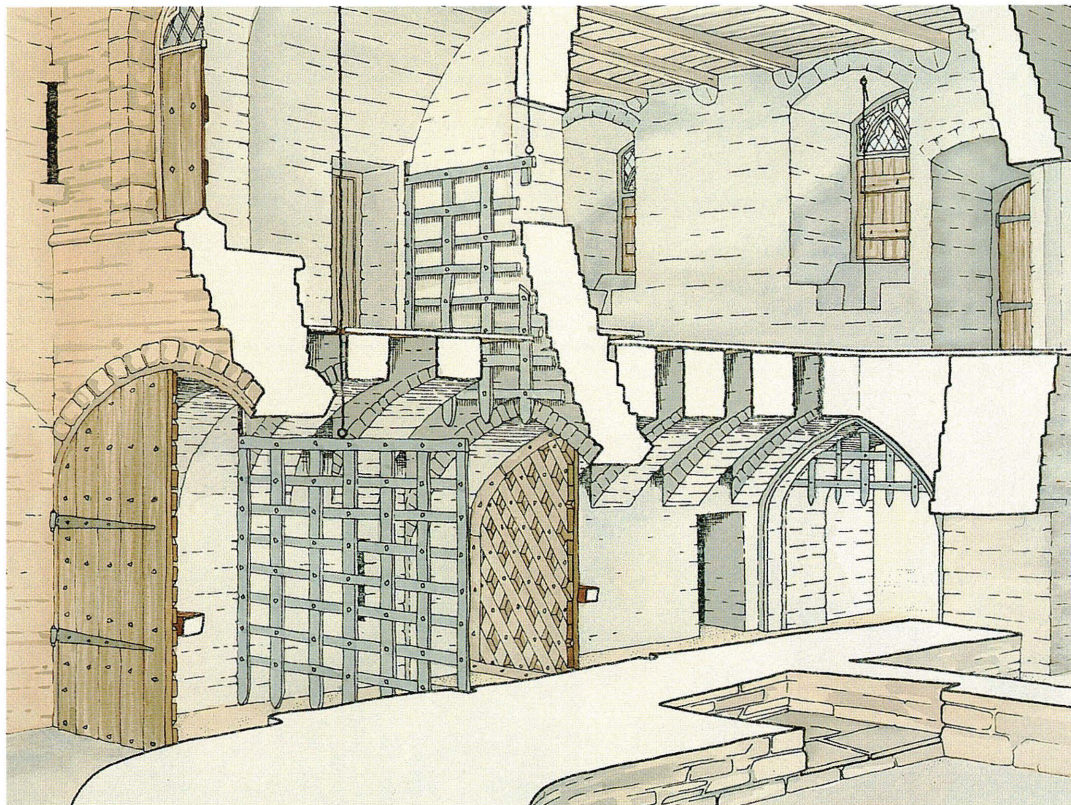
### The Gatehouse Guardrooms

On the left (south) of the gate-passage you will find a single ground-floor room (currently housing an exhibition). There is a wide arch across the centre of this chamber, but there is no evidence for a fireplace and its precise use is uncertain. The doorway in the south-west corner gives access to one of the stairs leading to the upper levels of the building. At the far end of the room (beyond the exhibition), the hole for the drawbar securing the outermost doors of the gate-passage comes right through the wall. Clearly, this was the point from which the outer doors were controlled.

Glancing up through the floorless interior, you will gain some impression of the layout and pattern of the upper levels. On both floors, the space above the gate-passage and this southern guardroom was divided into two rooms. Towards

*Left: Cutaway reconstruction of the gate-passage (Chris Jones-Jenkins, 1986).*

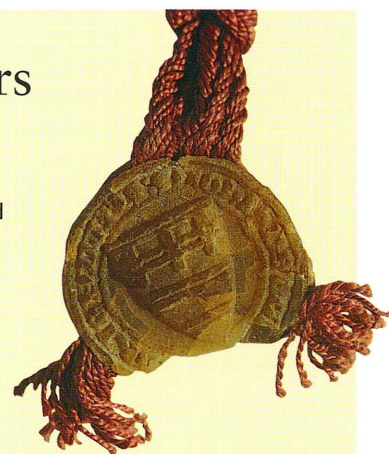
the inner ward courtyard, the larger and grander room at each level was fitted with two tall, stately window embrasures. Each of the two forward rooms was lit by a pair of smaller windows. All four rooms were fitted with fireplaces, with those in the large rooms facing the courtyard being particularly fine examples. The flues of these fireplaces rise to an impressive group of linked chimneys, of which a considerable fragment remains visible above roof level.

To the right of the passage are two ground-floor rooms with a communicating door. The first room, with a fireplace and lighting loops both to north and west, must have served as the porter's lodge. In the north-west corner is a door to staircase communication with the upper levels. As has been earlier suggested (p. 10), the stone cannon balls now collected in this room may bear witness to the cannonading suffered by the castle in one of the fifteenth-century sieges. As on the other side of the passage, one's eye is drawn up through the site of vanished floors and ceilings to the stately window openings and hooded chimney pieces of the rooms above.

## Sir John de Bonvillars

**S**ir John de Bonvillars was one of the distinguished Savoyard knights in the household of King Edward I. He was appointed deputy justiciar of north Wales and appears to have played a significant role in the king's castle-building operations between 1283 and 1287. In 1285 he was appointed constable of Harlech Castle at an annual fee of £149. It seems likely that the first-floor apartment in the gatehouse was quickly made ready to receive Sir John and his wife, Agnes, in the closing months of 1285.

Sir John died in the king's service at the siege of Dryslwyn Castle in August 1287. Agnes, his widow, assumed the constable's responsibilities at Harlech and presumably continued to occupy the same gatehouse apartment until 1290.

### Remainder of the Gatehouse

You may now wish to cross over to the far side of the courtyard and sit in one of the window seats to look back at a general view of the main inward façade of the gatehouse. It is undoubtedly one of the most striking compositions of 'military' (or perhaps more accurately 'fortified domestic') architecture of the thirteenth century to be seen anywhere in Britain.

Notice in particular that the six great windows (three to each floor) have all been reduced in height, probably at some early point in their history. You will see that their originally traceried heads are filled-in beneath the relieving arches with solid blocks of squared stone. It is interesting to note the way these grand openings contrast functionally with the pleasant irregularity of the little slits that light the stairs, at varying levels, in the two corner turrets. Hidden behind the turrets, as we shall see later, there is an additional grand window situated at either end of the top floor. These are visible from the wall-walk, and each retains fragments of its thirteenth-century stone tracery. Taken together, there is sufficient evidence to allow a reliable reconstruction of the original form of all eight windows.

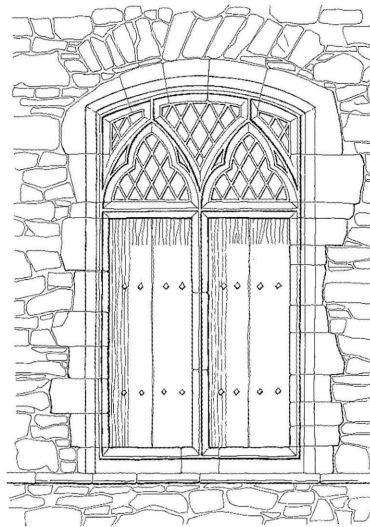
Note also the wide external staircase — 'a stately stayre' as it is called in one of the sixteenth-century surveys — which leads up from the courtyard to a door at first-floor level. This door enabled direct communication to be maintained at all times between the constable's lodging and the rest of the castle, even when the formidable barriers of the gate-passage were all closed, as generally they all were.

Now let us return across the courtyard and ascend this stair to the viewing platform provided in the doorway. From here you will see almost all of the arrangements in the two upper floors of the gatehouse. In effect, the four principal rooms at each level comprised a self-contained apartment (see plan, p. 25). To your right, in each case, there was a great chamber or hall [1] fitted with a handsome fireplace [2]. Indeed, the fireplace on the first floor may well have been 'the chimney in the chamber of Sir John Bonvillars', for the making of which Master Peter Morel and Albert de Menz — masons — were paid 7s. 6d. in January 1286. Both floors had two generous windows [3] towards the courtyard and another in the end wall [4]. A doorway in the south-west corner [5] of the chambers communicated with the southern

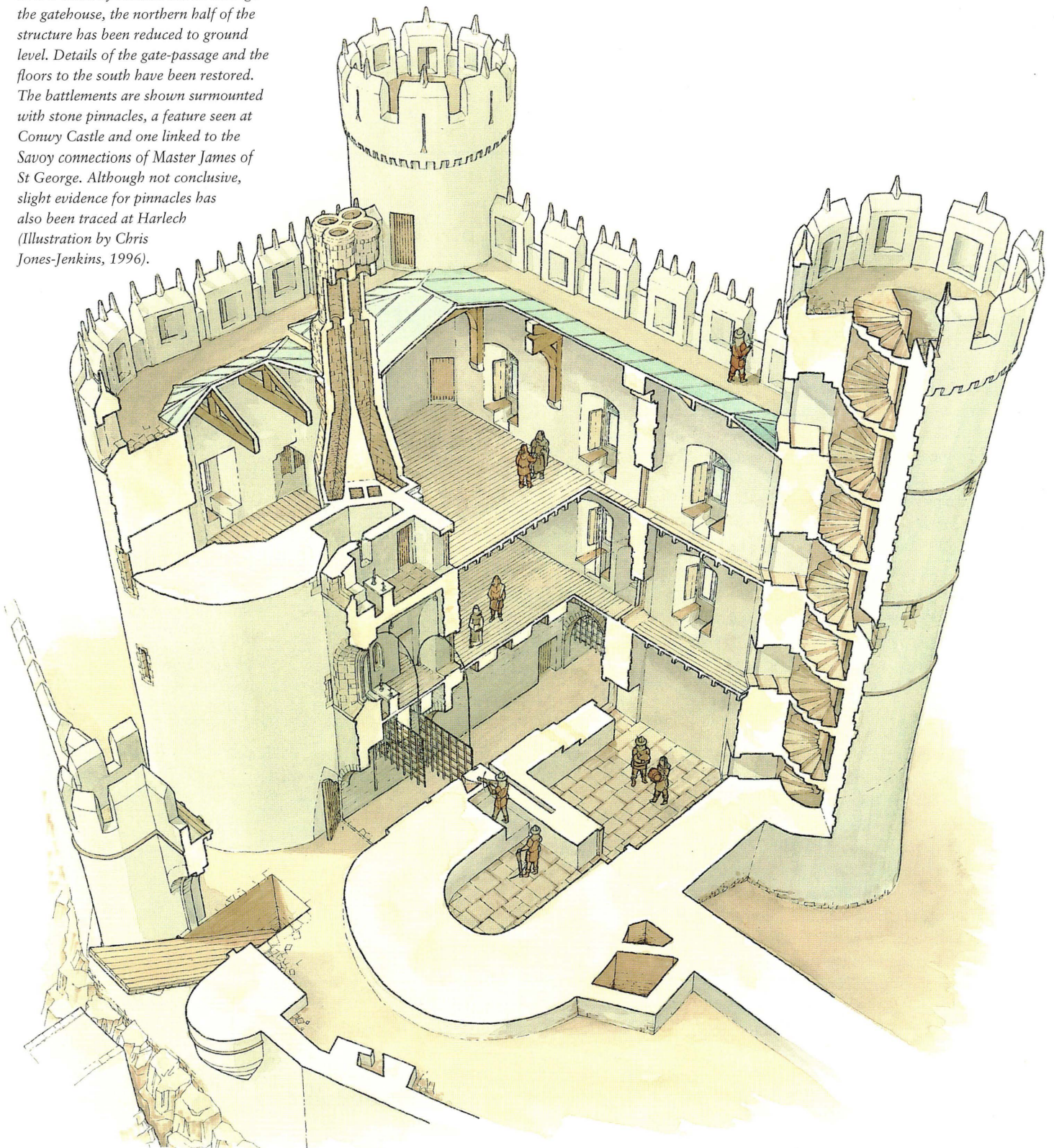

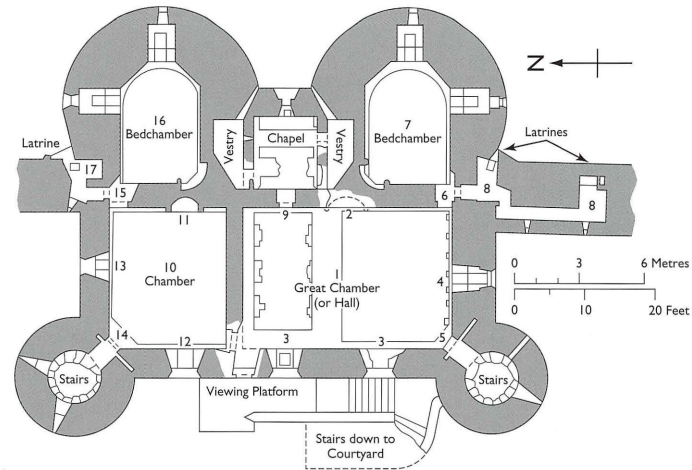
staircase. Another doorway in the opposite corner [6] led to the smaller chamber at the front of the gatehouse [7]. This same doorway also gave access to adjacent latrines, contained within the thickness of the walls [8]. Finally, directly ahead of the viewing platform, a third doorway [9] led into a small oratory or chapel, located over the front of the gate-passage, between the projecting east towers. At each level, the chapel was flanked by a pair of little vestibules or vestries.

To the left of the viewing platform, looking through the doorway, you will see a smaller room or chamber on both floors [10]. Each has a fireplace [11], and there is a single window towards the courtyard [12] and another in the north end wall [13]. In the north-west corner, a door [14] communicated with the north staircase. Once again, in the opposite corner, another door [15] led to the room at the front of the gatehouse [16] and — in the thickness of the wall — to an adjacent latrine [17].

In each floor level, the larger and smaller western rooms, or the hall and chamber of each apartment [1 and 10], were living rooms. By elimination, the rooms adjoining them in the eastern towers [7 and 16] would have been bedchambers. One must assume that the lower suite, with its direct access to

the courtyard and its control of the three portcullises, was the apartment of the constable and his family. He was the king's lieutenant and commandant of the castle and its garrison. The upper suite, one may suppose, but with more caution, may have been intended for the accommodation of visiting dignitaries — the king, the prince, the justiciar, the chamberlain of north Wales, or perhaps the sheriff of Merioneth.

## The Inner Ward

Next we shall consider the four towers of the inner ward in turn. For ease of description they are here named from the points of the compass as the north-east, south-east, south-west, and north-west towers. A survey of 1343 names them as the Prison, Garden, Weathercock and Chapel towers respectively, while a sixteenth-century survey names them as the Debtors', Mortimer, Bronwen and Armourer's towers. Let us begin with the two eastern towers — the 'towers towards the town' — which belong to the initial building period, and each of which contains a staircase giving access from ground to wall-walk level and down again.

### North-East Tower

The tower is entered from the corner of the courtyard to the north of the gatehouse. A reconstructed newel stair leads directly up to first-floor level, where a small lobby, with an opening off to a latrine, precedes the main room. The room itself has a corner fireplace and two formerly heavily barred window openings, once closed by internal shutters of which one of the hinges still remains. The floor of the room is now missing, but it contained a trapdoor which was the only means of entry to the deep circular dungeon below. The dungeon's only vent for light and air was a narrow slit sloping steeply up through the thickness of the wall. The second-floor room also has a corner fireplace, and both rooms are seven-sided.

The stair continues up to the wall-walk, passing a small latrine at the top. When you emerge on the wall-walk, you should turn to your left and follow the north-eastern wall as far as the gatehouse. Here you will see two doorways: one originally communicated between the gate and the wall-top; the second led from the gate to an adjacent latrine. To the right, you will see a traceried window remaining to full height.

Now you should retrace your steps and walk right around the wall-tops to the southern side of the gatehouse. From here there is a good view of the corresponding traceried window; this one lighting the great chamber on the top floor. Notice, too, the refashioned slate roof covering the latrine projection.

From here, you should descend back to the courtyard by way of the newel stair in the south-east tower.

### South-East Tower

The arrangement of this tower closely parallels that already noted in the north-east tower. There are again three levels, with two seven-sided rooms with corner fireplaces surmounting a circular dungeon-like basement. The basement has only a narrow slit shaft for light and air, sloping up through the thickness of the wall to emerge just below a first-floor window.

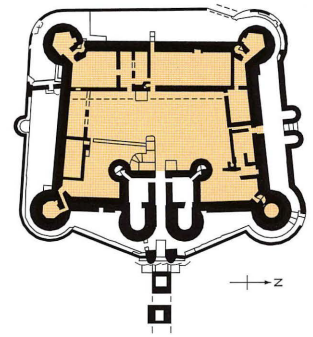
Having arrived back at ground level, cross the courtyard to the western towers which were built in 1288–89.

### South-West Tower and North-West Tower

A Master William of Drogheda was paid for the making of these two towers and their turrets in 1289. For the southern tower, which was 52 feet (15.8m) high, he received £117 at the task rate of 45s. per foot. For the northern tower, which reached 49½ feet (15.1m) in height, Master William's payment amounted to £111 7s. 6d., again at the rate of 45s. per foot. William was also paid £11 8s. for each of the turrets, both of which were 19 feet (5.8m) high, at a rate of 12s. per foot.

From this same year, we also have a record of £6 5s. being paid for dressing a total of 171 stone corbels. These were intended to support the turret parapets on the two western towers, and also to support the parapets of the two gatehouse stair turrets. Thirty-three of the corbels were dressed at a rate of 1s. each, and the other 138 at 8d. each; all of them are still in position today.

Each of the western towers contains four five-sided rooms, of which the two middle rooms in each case are provided with fireplaces. Doorways in the corners of the courtyard lead into each tower. In both of them the floors are missing and the staircases

ruined and inaccessible, so that it is now only possible to inspect the interiors from below. If the name 'Armourer's Tower', used for the north-west tower in the sixteenth century, was traditional, it may be that this tower contained the workshop of the 'artiller' mentioned in the original garrison establishment of 1284.

### **The North Range**

The positions of the various buildings situated around the edges of the inner ward courtyard are marked on the plan (inside back cover). For the most part their remains are fragmentary, and to view them it is suggested that you should stand in the centre of the courtyard. Beginning with the northern side, to the left there is an open yard leading into the north-west tower [1]. Next to this is the castle chapel [2], with its east and west walls remaining to full height. Corbels [3], beam-holes [4] and a

stringcourse [5] on the north curtain, and the terminating line of white internal plastering on its west wall indicate the position of the chapel's inner ceiling and its outer lean-to roof. Opposite the traces of plastering, there still survives the lancet head of the east window. The moulded bases of the chapel door jambs remain near the south-west corner [6].

To the east of the chapel, there is a gateway communicating with the outer ward, and thence through the outer north gate with the castle rock. Next again, to the right, are three windows [7-9] that lighted a group of service buildings, in one of which may still be seen the castle well [10]. Beam-holes in the wall above [11] indicate the height of their lean-to roof. Notice also on the north curtain wall a line of eight small holes [12] sloping up from left to right. These are putlog holes of the sloped scaffolding used in the original building works of the 1280s.



# The Savoy Connection with Harlech

The boundaries of the historic principedom of Savoy embraced an alpine region in what is today part of south-eastern France, western Switzerland, and north-west Italy. In the thirteenth century, the ruling dynasty of Savoy was of great importance. King Edward had close family ties with the dominion, and he was familiar with Savoyards who had come to England during his father's reign. Edward's visit to Savoy in 1273 provided an opportunity to renew these dynastic links. During his reign, there were many Savoyards among his close friends and the servants of the royal household.

Edward was eventually to engage the Savoy master mason, James of St George, as his chief military architect (p. 7). Other Savoyard craftsmen also worked on the construction of his north Wales castles. It is, therefore, perhaps not surprising to find several distinct architectural details which occur both in Savoy and north Wales,

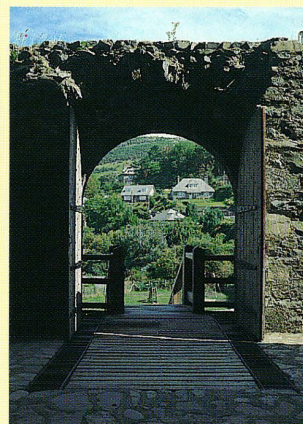
but which are rarely encountered elsewhere. Indeed, at Harlech there is evidence for all the main architectural links:

- The use of helicoidal or inclined scaffolding, as on the south tower of the gatehouse.
- The use of round-headed arches, with that between the solid turrets of the outer gate being a particularly good example.
- A distinct form of latrine shaft with a marked similarity between the corbelled turret at Harlech and those to be seen at La Bâtiaz (Valais).
- A common window design, with those in the gatehouse at Harlech (p. 23) bearing a striking resemblance to examples at Chillon (Switzerland).
- Evidence for the embellishment of the castle battlements by triplets of stone pinnacles, as at Conwy (p. 24).

### **The West Range**

If you now turn to look at the west side of the courtyard, on the right is the site of the great hall. It has four window openings towards the sea and there is a fireplace between them. The inner wall of the hall is now almost wholly demolished, though the gable wall at its northern end still stands to full height. A series of beam-holes and corbels, a dripstone and flashing groove along the outer wall mark the position of its inner and outer roofs.

To the left is the kitchen area, separated from the hall by a passage and the site of the buttery and pantry. A substantial fragment of the kitchen's inner wall still stands, and on it are three massive corbels below a dripstone. Together these indicate the position of the pent-roof covering a passage which appears to have run the length of the buildings on this side of the courtyard.

### **The South Range**

Against the southern curtain are the footings of two buildings. That to the left is traditionally identified as the granary, with floor beam-holes in the curtain wall indicating that it was built over a low basement. To the right is the site of a room which may represent the *Styngwernehalle* mentioned in the survey of 1343, presumably a Welsh timber-framed hall dismantled and brought here at the time of the building of the castle from a nearby place named Ystumgwern. On the curtain wall above, to left and right, note the lines of putlog holes of two sloping scaffold ramps, less easily picked out than those on the curtain opposite. Notice also, to the left, how the full thickness of the eastern curtain, apparently never completed, terminates on a sloping line some way below the finished top of the main wall.



## The Outer Ward

The outer ward, which closely encircles the curtains and towers of the inner ward on all four sides, provides the best viewing points for noting a number of features of interest. First, the horizontal constructional breaks mentioned above (pp. 6–7) are clearly visible about 15 feet (4.5m) above the ground along the whole length of both the north and south curtains. On the west, the vertical breaks can also be seen in the sides of some of the seaward-facing window openings.

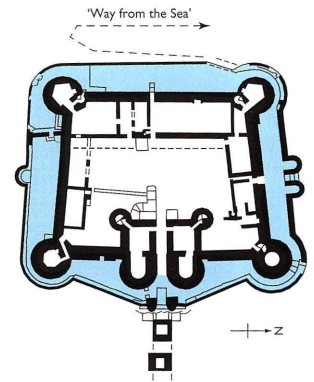
Walking around, you will also notice, on the dressings of most of the larger external windows at first-floor level, the marks of the iron grilles that formerly barred them. Lines of sloping putlog holes indicating the use of helicoidal scaffolding are prominent on the south tower of the gatehouse and the north-east tower, and especially so at all levels of the south-west tower. The bases, at alternating heights, of a number of the arrowloops of the destroyed outer curtain may be seen in what still remains of it on both the south and east sides. Notable also on the south side is the curve of the great projecting latrine and rubbish chute. Here, too, the depth of the rock-cut ditch is particularly impressive.

### The 'Way from the Sea'

The 'way from the sea' can best be seen by descending to and returning from the water gate at the foot of the castle rock near the railway station. The outward front of the water gate is no longer intact, though you will be able to make out the pit of a former drawbridge, and there is some evidence that the nearby rock was faced with stone to form a glacis (similar to the wall beside the water gate at Rhuddlan Castle). The wall encircling the castle rock makes an indent here, and this may relate to the former presence of a dock immediately outside the gateway.

From the water gate, 108 shallow steps lead up to an intermediate turret, where a fixed wooden ramp now occupies the position of a former drawbridge. The bridge and its turret are skilfully sited in an awkward re-entrant of the rock, where the south-west tower of the castle itself towers menacingly above them. From this 'upper gate' a further flight of 19 steps leads up to the grassy area below the south-west mantelet, from which there is a fine view of the south ditch, the south curtains (inner and outer) and the semi-circular latrine projection. The path leads on up to a gate at the foot of the north-west tower.

The parapet wall that protected the 'way' ends in the remains of a small gated turret against the side of the south-west mantelet,

whence a short flight of steps would have led down into the south ditch, which at this point fell sheer into the south-west ravine. The whole drama is lost today, the ravine being effectively blocked from view by a spinney of sturdy sycamores growing in it.

In this short description of the castle it is hoped the visitor's attention will have been drawn

to the main features of interest. No written description, however full, can convey the whole grandeur of Harlech as an outstanding monument of medieval military architecture, nearly as impressive and in essentials nearly as complete as when it was built more than seven centuries ago.



Although now isolated from the sea, Harlech Castle still dominates the coastal landscape, overlooking the morfa and sandhills which stretch out into Tremadog Bay.

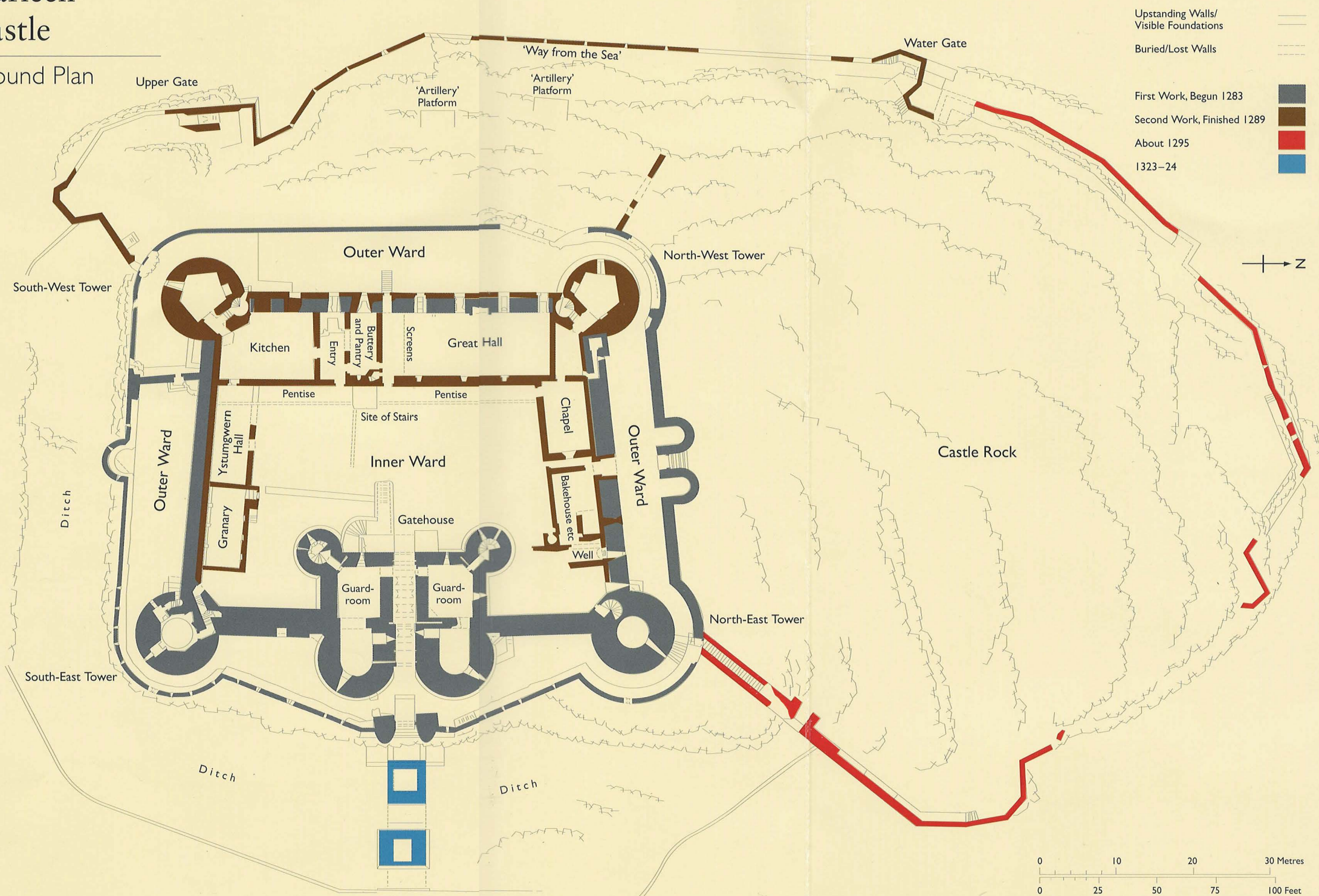

# Key Dates

- 1277 King Edward I builds or repairs castles at Flint, Rhuddlan, Ruthin, Hope, Builth and Aberystwyth at the end of the first war with Llywelyn ap Gruffudd — the prince of Wales.
- 1282 War resumes between Llywelyn and Edward I; the Welsh prince is killed.
- 1283 The end of the second Welsh war. Building work begins on the king's castles at Conwy, Harlech and Caernarfon. First phase of work at Harlech concentrates on raising the inner and outer curtains to a defensible height. Eastern towers and gatehouse begun.
- 1284 Denbigh, Hawarden, Holt and Chirk begun at about this time.
- 1289 Second building phase at Harlech completed, including the two western towers, the thickening of the inner curtain wall, the domestic buildings in the inner ward and the 'way from the sea'.
- 1295 Beaumaris Castle — the last and largest of Edward I's Welsh castles — begun in response to a revolt led by Madog ap Llywelyn. Additional defences constructed around Castle Rock at Harlech and a new tower built over or near the water gate.
- 1323 Harlech held by the sheriff of Merioneth in support of King Edward II against the Mortimer family. Eastern approach to the castle strengthened with two towers and a bridge.
- 1400 Owain Glyn Dŵr declared prince of Wales.
- 1404 Following long sieges, Aberystwyth and Harlech fall to Welsh troops. Harlech becomes the main residence for Glyn Dŵr's court and family.
- 1408 The castle under siege and damaged by English troops.
- 1409 Harlech falls to the English led by Prince Harry of Monmouth — the future King Henry V.
- 1461 Harlech held for the Lancastrians during the Wars of the Roses by Welsh constable, Dafydd ab Ieuan ab Einion.
- 1468 Under orders from the Yorkist king, Edward IV, Lord William Herbert of Raglan and his brother lay siege to Harlech with between 7,000 and 10,000 troops. The castle is surrendered.
- 1564 A survey records that the castle is in a state of poor repair, though the Merioneth Assizes are held here during the reign of Queen Elizabeth I indicating that at least the gatehouse is habitable.
- 1642 Outbreak of the Civil War; Harlech garrisoned for King Charles I.
- 1646 Parliamentary forces lay siege to Harlech.
- 1647 The castle is surrendered to Major-General Thomas Mytton and parts of it are rendered untenable.
- 1742 The Buck brothers are the first in a series of artists to visit and record the castle.
- 1914 Care of the castle transferred from the Crown to the Office of Works. Repair and excavations carried out.
- 1984 Responsibility for the care of Harlech transferred to Cadw.
- 1987 Harlech Castle — together with Beaumaris, Caernarfon and Conwy Castles — is inscribed on the World Heritage List as an historic site of outstanding universal value.
